ADDITIONAL PROVISIONS:

1. **Expiry Date:** This MOU will be in effect for one year from the signing date, and after that one- year period will be automatically renewed annually, unless a written notice of termination is delivered by either party to the other.
2. **Intellectual Property/ Resources Developed:** Both parties agree at the termination of the agreement that all intellectual property, and any changes made to it during the term of the relationship will remain the sole property of the organization where the intellectual property initially resided, and any future use will need to be approved in writing by the relevant organization.

3. **Termination:** Either Shri Shivaji College of Physical Education, Amravati or IPLA may terminate this MOU upon delivery of written notice to this effect.
