- 2) His services shall be governed by the rules as laid down by Government of Maharashtra, Statutes, Ordinances of the University and various Government Resolutions and circulars of the State Government issued from time to time.
- 3) His services can be terminated with one month notice on either side without assigning any reasons thereof.
- 4) He should join his duties within seven days from the date of receipt of this order failing which the order will be treated as cancelled.




